### **PARTICIPANT'S CODE OF CONDUCT**

- \_\_\_\_\_ 1. Participant is between the ages of 8 years of age and 14 years of age as of April 1<sup>st</sup>, 2020.
- \_\_\_\_\_ 2. Participant has reviewed the CNS General Rules as they apply to Participant Conduct, and agrees to abide by all applicable rules throughout the racing season. Participant acknowledges that RACING IS DANGEROUS, and that Driver shall be held to the same standards of personal responsibility as any Participant at CNS; regardless of age. Participant further acknowledges that all members of Participant's team; including but not limited to family members, friends, and crew members, shall be subject to the same standards as Participant.

Participant recognizes that his / her race car must meet all applicable competition rules and safety standards prior to entering the CNS Racing Surface; including but not limited to Practice, Qualifying, and Competition. Participant recognizes that CNS Officials have the final word as to whether or not race car is in compliance with CNS Rules and Standards, and further agrees that participation will be restricted until the race car is in compliance. Participant further acknowledges that CNS Officials have the final say as to all scoring matters, and understands that the only process for reviewing a scoring dispute is by filling out a Scoring Protest as described in the General Rules. Participant agrees to place all required decals on the race car as directed by CNS, and acknowledges that any failure to do so will result in a loss of points or award, or both.
